- b. The Big Spring Clean Up is on the horizon and need to plan date so insurance can be notified.
- c. The Next smaller councils meeting in at Shildon on Thursday 9th February at 2pm. Purdah training will be conducted by Roger Taylor, a lawyer from Hedleys. He is independent of County Durham so hopefully will quash the myths and tell it how it is.
- d. Election training at County Hall on Wednesday 1st March at 1800hrs. So far myself and Cllr Spencer are planning to attend.
- e. Andy Coulthard has sent a copy of the existing Castleside village action plan this will be revisited in June/July where new items can be added.
- f. An email was received from Lynn Holburn the secretary of the village hall reference invoicing for the room. Nothing more has been heard.
- g. There will be no extension of the referendum principles for Town and Parish Councils.
- h. This is the last year that BDO will be the external auditors. It is also the last year for smaller councils <£25000 requirement to submit annual returns to external auditors unless a question is raised.
- i. At a recent SLCC meeting we had a presentation from Morpeth's clerk on their neighborhood plan and it threw into question whether it is worthwhile. It appears that it is not worth all the work at this stage until Durham's plan is finalized since last plan in takes precedent!
- j. A training session covering Reserves and Annual Returns will be held at County Hall on 15th March 2017 at 1800hrs.
- k. The Fly the Flag event is on 13th March 2017 and arrangements need to made if it is to happen.
- I. The Battles Over Beacon on 11th Nov 2018 the parish council must decide if an event is to be held to mark this date.
- m. The Clerk is on holiday 25 Mar-1 Apr 2017. The Ordinary Meeting was changed to 23rd March 2017.

1617/130/7 Lead Miner – A formal request has been made to the Highways Dept to investigate whether the sculpture can be placed near the A68 at the top of Rowley Bank. It was RESOLVED that the sculpture should be commissioned and a place will be found in the village if Highways do not grant permission for siting it next to the A68.
